## Education and publishing:

■ **AIOSH** plays a major role in enriching the Arab library with many publications in various fields of OSH, by means of:

- Producing a lot of books, guides and periodicals depending on deliberate scientific bases using the international references.
- Translating many of ILO publications into Arabic language.

■ It produces annually many educational posters dealing with different topics in OSH.

## Technical support and advice:

The institute, within its available capacities, is always willing to grant technical advice to all parties and bodies concerned with OSH issues in The Arab Countries.

**1** Implementation of various studies for the benefit of businesses (public and private) on important topics, including:

- a comprehensive assessment of the work environment risks.
- monitoring and measurement of specific pollutants.
- recommend actions to control certain risks, including personal protective equipment.
- risk analysis in different stages of industrial processes and recommend measures of prevention.
- rehabilitation of facilities to obtain certificates of conformity with the international system of occupational health and safety administration ( OHSAS 18001 )

**2** Provide technical advice to resolve existing or potential problems , and development of legislation, rules and regulations ... etc.

### Training:

In the light of its annual work plan, the institute carries out many training courses for three labor parties in Arab countries:

- General training courses on the OHS knowledge
- Training courses for managers and employers dealing with administrative and economic aspects of the Occupational Health and Safety
- Specialized training courses dealing with:
  - occupational health and safety in various work sectors (oil and gas, building and construction, transportation ...)
  - various risks of work environment (chemicals, noise, vibration, radiation,...)
- Practical training courses on measurement and assessment of workplace hazards using different measurement devices and techniques (measurement of air pollutants, noise, heat ...)
